

**CITY OF DUBUQUE, IOWA
CITY COUNCIL PROCEEDINGS
SPECIAL SESSION**

The Dubuque City Council met in special session at 6:30 p.m. on March 8, 2023, in the second-floor Council Chambers of the Historic Federal Building, 350 W. 6th Street.

Present: Mayor Cavanagh; Council Members Farber, Jones, Resnick, Roussell, Sprank, Wethal; City Manager Van Milligen.

Mayor Cavanagh read the call and stated this is a special session of the City Council called for the purpose of conducting public hearings on certain Fiscal Year 2024 Department Budgets.

3. Community Impact Division (formerly AmeriCorps) Fiscal Year 2024 Budget Presentation: Heather Satterly, Community Impact Director.

4. Recreation Fiscal Year 2024 Budget Presentation: Dan Kroger, Recreation Division Manager.
